BROKEN BAY DIOCESAN ENROLMENT POLICY FOR PAYMENT OF FEES

- The Diocesan Policy applicable in all Schools within the Diocesan system is that any family which is genuinely unable to pay School Fees and levies, in whole or in part, and which meets the other conditions required for enrolment in the School, will be granted an exemption. The Diocese accepts, as an obligation, the support of its families with limited financial resources who desire a Catholic education for their children.
- A family experiencing difficulty in paying fees should discuss the problem with the Principal, who will resolve the matter after consulting the Parish Priest.

RULES RELATING TO THE PAYMENT OF SCHOOL FEES

1. School Fees are calculated for the School year and are billed in Terms 1, 2 and 3.
2. Fees are due and payable within 30 days of the issue of the account.
3. Non payment of School Fees can result in enrolment being suspended.
4. In cases of genuine financial difficulty, application should be made with the Principal for assistance.
5. Arrangements may also be made to pay the fees weekly, fortnightly or monthly. Application should be made on the appropriate form, available from the office.
6. Discounts are available for siblings attending Diocesan Systemic Schools within this diocese. Application for sibling discount should be made on the appropriate form.

PRIMARY SCHOOL FEES

The Diocesan School Fee structure is set by the Catholic Schools Office. Fees for 2020 are as follows:

ADDITIONAL FEES

Corpus Christi School has three additional fees to those set by the Catholic Schools Office.

- School based fee - \$1,261.00 per child.
This fee is paid on account three times during the year. It covers curriculum resources, sport levies and general sport expenses, specialist staff employed at the school (e.g. Music and P.E.) as well as excursions undertaken during the year (not including camps). It also covers cleaning of the school on a daily basis.
- If you have a 4th child at the school, the Tuition fee does not apply, however the School Based Fee is still applicable.
- P & F Maintenance Levy - \$99.00 per annum paid on account three times during the year (\$33.00). This optional levy assists to offset the costs involved in maintaining the school grounds.
- School Year Book – \$51.00 (Optional purchase)
